We have been pleased to have a strong link with TUHEDA and to have worked with them in presenting workshops. We are grateful to them for their cooperation with us.

The Tanzania Development Trust has had another productive year, its excellent programme of activities is reported in their own Annual Report. Congratulations to Jonathan Pace and his team for all that they have achieved.

Ben Taylor and Sue Mitchell have edited and produced excellent copies of Tanzanian Affairs and the Newsletter respectively. Our thanks to them for all their hard work.

Thanks are due to our whole committee and especially to our Vice Chair, Petronila Mlowe, our secretary Charlotte Pallangyo, membership officer Godlisten Pallangyo and treasurer Gabriel Mgambwa.

#### SEMINARS AND WORKSHOPS

# **BTS Seminars**

In July 2018 we had a seminar with the APPG on 'Current Investment Climate and Ethical Investment in Tanzania'. The main speaker was Peter Maila, investment director in the Africa Team at the CDC (formerly the Commonwealth Development Corporation).

In October we had a seminar on Towards Feasible Tanzanian Anti-Corruption Strategies with Dr Antonio Andreoni, Senior Lecturer in Economics at SOAS University of London ad Research Director of the Anti-Corruption Evidence (ACE) Research Consortium. Antonio talked about industrial development, manufacturing firms, ecosystems and technological change, governance and policies followed by a general discussion led by Godlisten Pallangyo.

We also had a seminar on Youth Employment and entrepreneurship in Tanzania in conjunction with the APPG Tanzania. The main speaker was TDT local representative, Benedicto Hosea, who spoke passionately about the amazing work he and his NGO in Zeze village, Kasulu, Kigoma have been doing to develop their community there. Benedicto also spoke at our AGM. His visit to the UK was sponsored by BTS.

In December we had a seminar at SOAS on Tanzania's Energy Sector and the Stiegler's Gorge Dam. Barnaby Dye studied this dam as part of his doctorate and presented on the project's recent history, its position in Tanzania's energy sector and place within government policy. The megadam has long been controversial, sitting in a world heritage site and upstream of rich farming, fishing and marine ecological and economic areas. Having been resurrected under President Kikwete, with Brazilian support, the dam is now a flagship for President Magufuli. Dr Antonio Andreoni (SOAS University of London and SOAS-ACE Research Consortium) has been working on an ACE project focusing on feasible strategies for incremental reduction of unproductive rents capture in the energy sector in Tanzania. He presented some preliminary results of the project and discussed a number of alternative energy technology mix solutions for the energy sector in Tanzania, including a comparative assessment of the role that mini-grids can play in an energy sector transition. There is a longer write up of this seminar in the BTS Newsletter.

# **BTS Workshops**

The first of a series of TUHEDA/BTS Health talks, entitled Diabetes; Food Quality and Nutritional Requirements, took place at South Bank University, London on April 13th with expert speakers from the medical Diaspora communities and others, addressing health related issues. Speakers were Petronila Mlowe (Senior Food Safety Officer, BTS Vice-Chair, Trustee TDT and TUHEDA) and Dr Gideon Mlawa, Consultant Physician in Diabetes and Endocrinology at Queen's Hospital London (Romford) UK and a TUHEDA member.



On May 4th at South Bank University London, BTS Vice-Chair Petronila Mlowe ran a workshop, Implementation of Traceability Systems for Tanzania's Agricultural Products. This workshop was primarily for members of the Diaspora who are exploring the possibilities of importing agricultural products into the UK. We were privileged to have two high commissioners in the audience – H.E. Dr. Asha-Rose Migiro Tanzanian High Commissioner and H.E. Julius Peter Moto, the High Commissioner of Uganda.

Details of upcoming seminars and workshops are on our website and Facebook page. Everyone is very welcome. There is time to ask questions and generally network at the end of each seminar.

# **Tanzanian Affairs**

The Tanzanian Affairs team of contributors and editors produced three more issues of the journal, which continues to be well-received by society members and others with an interest in Tanzania.



The temperature of Tanzanian politics continues to rise, with President Magufuli's hard-line approach attracting both passionate supporters and strident critics. This reaches beyond electoral politics into most areas of the Tanzanian economy and society – most notably mining and natural gas, conservation and tourism, reproductive rights and the media.

Though this inevitably raises some challenges, Tanzanian Affairs endeavours to stand back from the fray and to maintain a strong commitment to objectivity, balance and truth. We report the facts, as best we can.

Key articles in the past year include political

developments under President Magufuli, the controversial Stiegler's Gorge dam and hydroelectric power plant in the Selous, and the ongoing reinvigoration of the national airline, Air Tanzania.

Beyond the news sections, the book reviews remain very popular. Highlights this year include reviews of *Taken for a ride*, Matteo Rizzo's examination of the mass transport systems of Dar es Salaam, *A new history of Tanzania*, by Isaria Kimambo and others, and Karim Hirji's memoir, *The travails of a Tanzanian teacher*.

# Minutes of the 43rd ANNUAL GENERAL MEETING of the Britain Tanzania Society held on 27th October 2018 at 2.00pm at St Mary at Hill Church, Lovat Lane, London, EC3R 8EE

- 1 **Welcome.** The Chairman, Mr Andrew Coulson welcomed the 61 people present.
- 2 **Minutes of the 42<sup>nd</sup> AGM**, held on Saturday 28<sup>th</sup> October 2017 having been circulated were agreed by the meeting as a correct record and signed by the Chairman.
- 3 **Matters arising.** No matters arising were reported.
- 4 **Annual Report of BTS(UK)** for the year ended 30 June 2018. The Annual Report had been published on the society's website and hard copies were available at the meeting. The Chairman summarised the year and thanked people for their work for BTS during the past year. The Annual Report was unanimously adopted by the meeting.
- 5 **Annual Accounts of BTS(UK)** for the year ended 30 June 2018. Gabriel Mgambwa presented the accounts for the financial year and said the financial position of the society was in good order.

Janet Chapman proposed that the accounts be accepted, Petronila Mlowe seconded the motion and the meeting unanimously accepted them.

Jonathan Pace, Chair of TDT, presented the report which is posted on the TDT website. Hard copies were available at the meeting. A summary of the year was given on funds, highlights and the impact of TDT. Elizabeth Taylor proposed that the report be accepted and Janet Chapman seconded. The report was unanimously adopted.

Detailed accounts had been circulated in the Annual Report and a summary was provided by Robert Gibson on the current fund position and projects.

The accounts for 2018/19 show a year end surplus of £6083.57.

There were no events expenses as the summer event was delayed into the new financial year.

At the end of the year, there was a balance of £9305.63 in the current account and £5640.87 in the deposit account.
