INTRODUCTION FROM THE CHAIRMAN

It is an under statement to state that this has been a very odd year.

We started the year full of optimism and on 27th July we held our first social event for some time. The 'Tanzanian diaspora and friends of Tanzania Summer Event'. It was held at the church of St Mary-at-Hill Church in Billingsgate, where a Swahili speaking congregation regularly meet. Over seventy people: BTS members, friends and families came together for that event. We were entertained by music from Freddy Macha and Kitoto plus Mvulla Mandondo and Fabra Moses, also a fashion show from Neema, all well received. We were well fed with Tanzanian food prepared by the ladies of the Swahili congregation. We are very grateful to all who made that event such a success. It had been our hope to hold a similar event in June of this year; and when that had to be cancelled our hope had been to combine the AGM with such an event. Current circumstances mean that the AGM is to be held on Zoom.

The need to go 'on line' may limit our social interaction but has its advantages in making it possible for those who live far from Central London and those who live in Tanzania to be able to join in with Zoom. This was a clear advantage at our seminar in May of this year. We trust that it will also be an advantage at our AGM.

Our thanks go to Janet Chapman, Ben Taylor and Andrew Coulson who have arranged an interesting set of seminars throughout the year. These events have been at a high standard. I encourage you to attend wherever possible. It is our hope that we will be able to combine live and online involvement.

We continue to have a good link with TUHEDA who have held events to keep people informed about the Coronavirus and other health issues. We give our thanks for their efforts and look forward to future cooperation.

The Tanzania Development Trust has again given support to many projects, reported in their own Annual Report. In particular they undertook a fundraising campaign to supply PPE to local hospitals and

clinics. Congratulations to Jonathan Pace and his team for all that they have achieved.

Ben Taylor and Sue Mitchell have edited and produced excellent copies of Tanzanian Affairs and the Newsletter respectively. Our thanks to them for all their hard work.

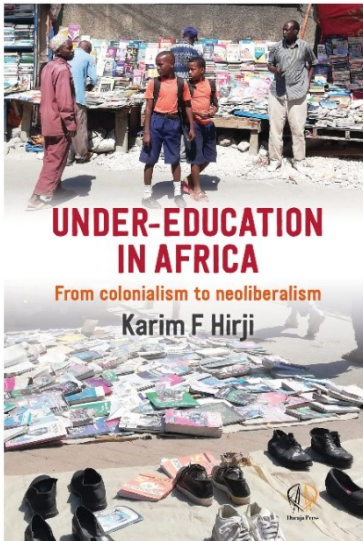
SEMINARS

Global warming in Tanzania – how big is the problem and what can be done?

This was the topic of the seminar held on 2 September 2019.

Andrew Coulson spoke of the impacts of climate change on Tanzanian life, agriculture and fishing. Jo Anderson spoke about the work of Carbon Tanzania, which was set up in 2011 to support the retention of forests. Tim Clarke, formerly EU ambassador to Tanzania, spoke of EU lead projects introducing climate change technologies. His hope is that the government will take up the new challenges and opportunities provoked by climate change.

Under-education in Africa: From Colonialism to Neoliberalism



A seminar in the Brunei Gallery Lecture Theatre at SOAS on Monday 25 November launched a new book by Karim Hirji. This book brings together his writing on education from the 1970s to now.

The seminar looked at Hirji's work, in the context of the outpouring of creativity at the University of Dar es Salaam in the 1970s. It was introduced by Andrew Coulson who has written extensively about Tanzanian political economy. Other contributors were Colin Leys, better known for his critical work on private capital in the UK NHS, Abdul Paliwala, Emeritus Professor of Law at the University of Warwick, and George Hadjivayanis, all of whom were in Dar at that time.

Covid Seminar

On May 28, 2020, BTS hosted an online seminar on the Coronavirus outbreak in Tanzania, chaired by Ben Taylor. The three speakers were opposition leader, Zitto Kabwe of ACT Wazalendo, former president of the Tanganyika Law Society, Fatma Karume, and Roland Ebole, Amnesty International Regional Researcher for Tanzania and Uganda. Each presented typically passionate assessments of the early stages of the Coronavirus outbreak in Tanzania and of the government response, and a lively discussion ensued.
