

BTS Seminars

The following seminars, organised by BTS and TDT, took place during the year:

Tanzania's Development Trajectory: A Long Durée Perspective 20th January 2021

Chambi Chachage, Lecturer at Princeton University, shared an outline of key moments in Tanzania's development together with an assessment of the current situation.

Jesper Katomero - an experienced researcher on water sector governance and accountability based in Tanzania.

Aikande Kwayu - a Development Consultant at Bumaco Ltd. (Tanzania) and a Honorary Research Fellow at the University of Wisconsin-Madison.

Ruth Carlitz - an assistant professor of Political Science at Tulane University (USA), where she teaches courses on International Development and African Politics.

Constantine Manda - the Co-founder & Director at the Impact Evaluation Lab, Economic and Social Research Foundation (ESRF)

Blandina Kilama a senior researcher, at REPOA and the CEO of the Economic Society of Tanzania.

Julius Nyerere: Development as Rebellion - a Biography - Book Launch 9th December 2020

Julius Nyerere led Tanzania to Independence – and is revered as the Father of the Nation. This event launched a new three volume biography of him.

- Volume 1 on his early life and influences, by Saida Yahya-Othman;
- Volume 2 on the path to Independence, by Ng'wanza Kamata; and
- Volume 3 on the path from capitalism to socialism and back again, by Issa Shivji.

Saturday 24th October 2020 2.00 to 4.30 pm

1. **14.00 Welcome** BTS Chair Elizabeth Taylor welcomed our first Zoom AGM; 83 people were present

Elizabeth welcomed members from BTS Scotland and Tanzania

Elizabeth passed on the sad announcements and on our deep condolences to the families of TrevorJaggar on their recent loss; and to Danny Mwasandube and Petronella on the recent loss of their son Lugano

2. An address from H.E. David Concar, UK High Commissioner to Tanzania.

David spoke under three themes:

- I. His own background including recently his work as Director of Protocol at the Foreign and Commonwealth office, and as Ambassador in Somalia, with a focus on famine alleviation and the challenge of terrorism, as well as his initial training as a research scientist and a journalist.
- II. The work of the staff at the High Commission including its' work on Development, Trade, Business support and support for Border force issues and International crime
- III. His impressions after 2 months including positive awareness of progress in education, infrastructure projects to remote areas and a commitment to tackle corruption; as well as questions on the approaching elections, consolidation of power, the business environment and covid response whose positive story is being hampered by a halting in the collecting of data
- 3. Those active within BTS and TDT both in the UK and in Tanzania gave presentations of their work
- a. **Marumba Community Development** involving Eucanaid/TDT and African Palms slide displayed with more information available on the 45th anniversary meeting 28th November

- b. **Hope for Girls and Women's Empowerment:** Rhobi Samwelly a presentation for Hope for Girls and Women's Empowerment. Janet also mentioned her particular thanks to FAWCO for their invaluable assistance this year. https://hopeforgirlsandwomen.com
- c. **Mboni ya Vijana**; Benedicto Hosea a presentation on the work of Mboni ya Vijani. Janet mentioned a correction that the 200,000 not 200 had been involved in the big give campaign.
- d. **Ikondo School** Alpha Ngailla gave a presentation as a teacher and local rep on his work in the school especially in entering and winning the prize at the **schools enterprise challenge**, benefits of entrepreneurial and business and practical skills being learnt by 20 students in the club running the chicken project.

- h. Sub Saharan Advisory Panel: Fadhili Maghiya, Cardiff, Wales. A presentation on his involvement in the work of the Sub Saharan Advisory Panel showing a range of activities of the diaspora in Wales and abroad. Key quote: "If you want to go fast, go alone, if you want to go far, go together"
- i. **Street children**: Kevin Curley; Spoke with a presentation on the lessons learnt in supporting street children, their challenges and lessons learnt when returning to home and to school.

- Wales project to provide diabetes instruments. TUHEDA were thanked for their support and advice during the Covid appeal

Independent Examiners Report to the members of the Britain Tanzania Society.

I have been appointed by the officers of the Society as Independent Examiner.

As such I have examined the Accounts for the year to 30th June 2021 as prepared by Mr Jeremy Lefroy (Treasurer).

Mr Lefroy brought to my attention that in the preceding year the accounts that had been prepared were erroneous, and that further unauthorised transactions had been carried out in the early period in this year on which I am reporting. This had been discovered by the committee and prompt action had been taken, and Mr Lefroy appointed as Treasurer.

Following the discovery of the unauthorised transactions the Committee put in place control systems to ensure this cannot happen again.

As an Independent Examiner my role is less onerous than that of an auditor, in as much that I am only required to express an opinion of reasonableness of the accounts presented.

However, under the circumstances, I have thoroughly examined the Society's transactions in this year, alongside the bank statements, and also the Committee's Minutes as they pertain to the accounts. This examination was made simple as all transactions go directly into or out of the bank. No cash is involved, nor the writing of cheques.

I also asked to see evidence of the authorisation system now in place, and the internal controls.

Lastly, the officers of the Society have reassured me that there have been no transactions pending at, or arising after, the year-end that might materially affect the solvency of the Society.

In my opinion, the accounts presented for the year to 30th June 2021 show an accurate reflection of incomes received and expenditures made in the year; and the Reserves of the Society at the year end. Further I also consider that the checks and internal reports now put in place will be adequate to ensure control of the accounts.
