REPORT OF THE CHAIR OF BTS (UK)

1. RELATIONS WITH GOVERNMENTS

The Society's relationship with the governments is as important as our expanding contacts with communities in Tanzania in strengthening the friendship between the two countries. This friendship is our fundamental purpose.

Her Excellency Mrs Mwanaidi Maajar, the Tanzania High Commissioner has supported our work and attends many of our events. Members have been privileged to be invited to dinners at her residence, and a reception on Tanzania National Day. The book launch of "The Magic of Mikandani" by Trade Aid hosted by the High Commission was a great success.

The British High Commissioner Philip Parham and his wife Kasia during their stay in Dar es Salaam were strong supporters of BTS. They travelled extensively in the Regions. The new website he developed has proved very useful for UK visitors to Tanzania [http://ukintanzania.fco.gov.uk/en/]. Kasia on her part has done a tremendous job helping with a programme for disadvantaged boys who survive on the streets of Dar es Salaam. Their story is presented in a book "DogoDogo" written and illustrated by the boys themselves produced by Kasia and published by Macmillan (ISBN 978-9-987-37302-4). It is being used as a reader in many schools in the country and getting wide circulation by members of the Society here.

Diane Corner, the current High Commissioner appointed last Spring has already

been in contact with BTS (TZ) and will address their annual Meeting in November.

Stephen O' Brien, MP, is Chair of the All Party Group on Tanzania and a committed member of the Society. He chaired a fascinating meeting in November in the House of Lords convened by the Africa Research Institute on Bunge Lenye Meno, A Parliament with Teeth. A number of members of the Society took part - coming H.E. Diane Corner presenting her from as far away as Edinburgh - and heard the Auditor General, Ludovic

Utuoh, present the case for parliamentary oversight of government following the Richmond Power Supply contract scandal. At a subsequent meeting, Ludovic led an open discussion on political changes and corruption in Tanzania.

Executive Committee will present a proposal for the election of Trevor Jaggar as a Vice President of the Society, a proposal fully endorsed by the UK Committee.

Members paid a courtesy call on the British High Commissioner in her office on the 21st April 2009 and were invited to the Queen's birthday celebrations at the residence on 18th June 2009 where they had an opportunity to meet Diane Corner and Peter Stoker.

The Chapter provides us with a very reliable perspective on news and issues of concern to BTS UK. Members who visit Tanzania find their advice most helpful.

13. BRITISH AIRWAYS GENEROUS ASSISTANCE

We were very fortunate indeed to have been selected by British Airways as one of its Charities of the Year in 2008. This has been a tremendous help for institutions in Tanzania linked to charities, towns or schools in the UK. The airline granted four free air freight consignments of 500 kgs each. The shipments were allocated as follows:

 Medical equipment for Muhimbili School of Nursing, assembled by Petronella Mwasandube, much of it from an NGO - Aid to Hospitals Worldwide;



11. SCOTTISH GROUP

Ann Burgess reports that the Group continues to meet in Edinburgh. There are approximately 80 members and friends on the mailing list although many are unable to attend meetings. Despite having to change venues there has been a full programme of meetings. The Group is closely involved with the Tanzania Edinburgh Community Association (TzECA), and, on an individual basis, supporting charities and projects in Tanzania.

Meetings included:

In June, Frederick Longino spoke on 'Accusations of child abuse linked to beliefs in witchcraft and religious exorcism' – the focus of his PhD thesis; and a number of people described projects with which they are involved in Tanzania.

In October, Matt Norton described the schools project he heads in Kenya and Tanzania.

On December 5^{th} several members attended the large and very successful Launch party for TzECA which was attended by the Tanzania High Commissioner.

In January there were talks by: Niwael Mtui (on the methods used to measure the seroprevalence of contagious bovine pleuropneumonia (her PhD thesis), and by Monica Mhoja on the 'Dignity Alert and Research Forum' an INGO concerned with human rights of African women, children and young people.

In April, after discussion with TzECA the Group held a joint TzECA/BTS Round Table meeting at which people who are involved with charities and projects in Tanzania discussed their positive and challenging experiences.

2. EVENTS

In July 2008, we were fortunate to have been able to entertain Tanzanian bishops and their wives attending the Anglican Lambeth Conference in Canterbury. Some of our members met the bishops from Tanzania and a number of other countries on their arrival at Heathrow and guided them to their UK hosts in the dioceses. On 28 July BTS hosted a lunch in Canterbury for the twenty six Tanzanian bishops and their wives, led by Archbishop Makiwa, and their UK hosts. There were 102 guests, including many Society members. 3. VISITS to TANZANIA

Many BTS members go to Tanzania each year to work with charities or on business assignments. We unfortunately do not hear about all of them. Committee members who visited included Richard Barton-Wood, David Brewin, Paul Harrison, and Sally Parson with her husband climbed Kilimanjaro to raise money for TDT. Leo Tesha spends time each year in Kilimanjaro Region and my wife and I were there for nearly six weeks in the Autumn. Hildebrand Shayo had two trips to advise on opportunities for exports to the EU and one for the Ministry of Natural Resources and Tourism funded by the government of Finland. Aseri Katanga went more than once working with Computer4Africa, a charity he chairs. And Abubakar Faraji was also there. Thus 10 out of 24 committee members were there and we know of many others from link groups.

This, together with our friends in the Tanzania Chapter, may help to explain why we are usually able to respond constructively to requests for advice and assistance. All of the committee members who go bear their own expenses. There is no call on BTS or TDT funds.

The journey Liz and I made in Tanzania took us to 10 Regions and 24 projects – twelve of which are covered by Robin Newell's TDT report, nine projects are those TDT assisted in the past and five were new requests. 8. COMMITTEE MEETINGS

The Executive Committee and the Tanzania Development Trust Committee each met on four occasions, on Monday 15th September 2008, Thursday 27th November 2008, Friday 27th February 2009 and Wednesday 20th May 2009. During the year, Paul Harrison resigned from being a Co-opted Member of the Tanzania Development Trust Committee, due to work commitments. He will, from his new location in Nairobi, continue to support the Committee's project work in Tanzania.

9. ANNUAL GENERAL MEETING 2008

The 2008 AGM was held at the School of African and Oriental Studies (SOAS) on 11 October. In his address the Deputy High Commissioner, Mr Chabaka Kilumanga, emphasized the role of the Society in fostering co-operation and understanding between the two countries. He praised the work of the outgoing Chair, Mr. Trevor Jaggar who had done so much to enhance the ties between the two countries.

Trevor in his remarks noted that, after serving for 17 years as a member of the

It is difficult to select which part of the trip was most exciting, maybe the visit to Nkonkwa on the shore of Lake Tanganyika. It took five days to get there from Dar es Salaam and the last leg of the journey involved 10 hours along bush tracks. We spent two nights there sharing the house of Pastor Damas, the project manager. Nkonkwa has no electricity, no mobile phones, no email, no bank - teachers have to take the boat to Kigoma to collect their salaries Three weeks before we arrived 6 people died of cholera at the neighbouring village of Buhingu. The primary school has 650 pupils and 6 teachers – only three were present when we were there. Each child only had three out of the seven periods in a day with a teacher in the classroom; the rest of the time they were on their own and very little school work was done..

The Nurse's House ... is really good and attractive house. I will send you the photos after the full completion of this House and the new village Nurse. I have been with the District Medical Officer in his office here in Kigoma discussing about the issues. He has processed already that whenever the House is completed the Nurse can be sent across. I know that you continue to seek funding that will manage to complete these two teachers' houses and for other new projects. We are more grateful for the work you are doing on behalf of us. Thank you in advance. Best wishes, Pastor DAMAS

The teacher's house and the nurse's house which TDT financed are vital to the welfare of the village. A nurse has already come to live in the village since Pastor Damas' letter.

4. VISITORS from TANZANIA

- Flora Mboya, an experienced physiotherapist who is studying for her Masters at Southampton University, stayed with us at Christmas.
- Leticia Kashasha, Principal of the Livestock Training Institute at Buhuri in Tanga Region spent a night with the Fennells on the completion of a course in Devon..

5. PUBLICATIONS AND PUBLICITY

Tanzanian Affairs.

David Brewin continues to maintain a very high standard in the regular issues of Tanzanian Affairs. A prominent politician in Zanzibar, whom I met during a visit to Zanzibar in November 2008, spoke in glowing terms of the balance and quality of the commentary on events in Zanzibar and said his ministerial colleagues were on the look out for further issues.

Much of the content of *Tanzanian Affairs* during the year was devoted to the determined efforts of the authorities to deal with corruption including the arrest or removal from office of many very senior politicians and businessmen on corruption charges, eventually culminating in the resignation of the Government and the appointment of a new Prime Minister and ministers. Significant stories were published on President Kikwete's growing international prestige, the failure of efforts to bring the two main parties together in Zanzibar, land use planning, connectivity for remote schools, the controversy over whether Tanzania and/or Zanzibar should join the 'Organisation of the Muslim Conference' (OIC) and how the credit crunch is affecting Tanzania.

The macro economic situation is well summarized in the report of a meeting organized by President Kikwete and the IMF in March (*see Tanzanian Affairs No 93*). With the severe global recession there is increasing concern among members about

the impact upon poverty and human welfare in Tanzania.

Donovan McGrath joined the editorial team of Tanzanian Affairs during the year. Lecturer in Media and Communications at SOAS and part-time Lecturer in Swahili, he holds a BA (Hons.) degree in African Languages and Culture and a Master of Arts degree in Film and Visual Culture. He co–authored the book "Colloquial Swahili" and has taken over responsibility for the section headed "Tanzania in the International Media". Jacob Knight continues as a co-editor and does a sterling job in maintaining the journal's website. Mary Punt is Distribution Manager and Debbie Simmons is responsible for Advertising. John Cooper Poole is in charge of

book reviews assisted by Marion Doro in the USA. David has a great team. I am grateful to them.

Newsletter.

Members all over the country and abroad look forward to the Newsletter and find its broad coverage fascinating. It continues to be published three times a year (January, May and September) and is also available (in colour) online via the BTS website. The editor, *Richard Barton-Wood*, aims to include notices of meetings and news about members and events, both in the UK and in Tanzania. The Newsletter contains regular reports of seminars and other features of interest to members. Richard likes to include updates on some of the projects supported by TDT as well as news of initiatives by other NGOs and any organisations working in Tanzania. All this depends on him receiving copy in good time, preferably with digital photographs. Letters, comments and opinions from members are especially welcome! Website

The Society's website (www.btsociety.org) has proved to be a useful tool for informing the public about ourselves. But as web technology moves on rapidly, the site is becoming rather dated, both in its look and feel to users and in its ease of use. Also, there is just one site for both the Society and the Tanzania Development Trust which could be confusing.

Therefore, *Tim Watkins-Idle*, the website manager, after extensive discussions with the Committee, has arranged for two new linked sites to be commissioned which will be clearer and more interactive. They will have more information about the Society and the Trust, and be easier to maintain and update. For example, the new Trust website has a map of Tanzania with pins indicating where we are supporting projects, and when pins are clicked there will be details about the particular project.

Draft sites have been built, and feedback from a variety of people has been collected for incorporation into second drafts, which we expect will become the new sites in a few months time. I thank Tim for all his hard work and look forward to the new websites being available.

6. <u>SEMINARS</u>

A successful seminar on *Trade and the East African Community* was held on 29 November 2008 at SOAS, in collaboration with the Centre of African Studies , and the Royal African Society. The speakers were David Potts of the Department of Development and Economic Studies University of Bradford and Simon Cowan Africa economist , Citibank. The illustrated presentation gave a comprehensive review of developments in Tanzania since Independence, highlighting the central role of foreign exchange, commodity terms of trade and government policies.
